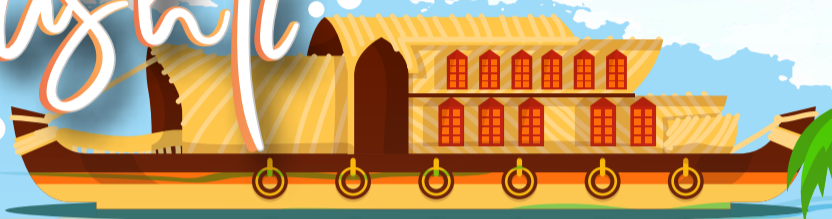

## Instructions for Sabarimala Temple Visit

- All participants will have to observe the dress code permitted at Sabarimala Temple (Black or Kavy Lungies, Kurtha, Bermooda & TShirt). There will be a two hours trekking of four kilometers with 40 climb at limited places. Dolly facility (carrying devotee in chair) will be arranged on advance intimation at an extra cost (up and down) perhead.
- Ensure physical fitness before the trip.
- Persons without "Irumudi Kettu" are not permitted to climb the 18 holy steps. "Irumudi Kettu" will be arranged from Pampa for those who inform us in advance.
- Plastic is strictly prohibited as per Honourable Kerala High Court Order.
- Women between the age group of 10 and 50 years will not be permitted as per temple rules. Other women delegates should mandatorily carry original ID card forproving Date of Birth
